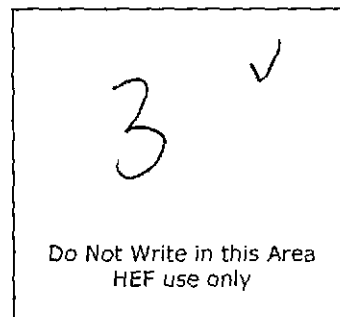

1. What is the major educational need this grant addresses? Please give grade level and academic area.

The Ladibug Document Camera HD will help with the use of resource materials to aid in ELA, math, social studies, science, and geography. Classes will be able to expose students to a large number of nonfiction writings to enable proficiency in narrative, opinion, and informative essay writing. The document camera will also aid in social studies with the availability to show many documents from the Bill of Rights and Constitution on the smart board along with biographical novels. Science will be able to access experiments and directions that are available in other resource books. Reading will be able to have read alongs with more books and each student will be able to follow along with the stories and increase comprehension and vocabulary.

Some teaching resources cannot be found on the internet to be used with our smartboards. The document camera will capture 3D objects and images so large groups of students will be able to view resources together and learn at a faster pace. We would like to help increase students' vocabularies and reading levels using the document camera.

2. Approximately how many pupils will be affected by this project, both directly and indirectly?

Students affected by this grant will be all of the 4<sup>th</sup> through 7<sup>th</sup> grade students with special needs (approximately 70 students). Students will benefit in all subject areas with the use of this technology.

3. Describe your grant including methods, materials and objectives. Foundation grants are intended to fund a creative teaching plan, so if equipment or materials are requested it should be clearly stated as to why these are an integral part of the plan.

Teachers will be able to use the document camera to bring items into the classroom that before had to be copied in black and white or put on transparencies. For example, The Constitution of the United States or the Bill of Rights or pictures of the Civil War; reading passages or nonfiction books; poetry, prose and other writings can be displayed for the students to experience in the classroom. The camera can be used to magnify manipulatives so that all students can see them. The document camera can be used to review quizzes and assignments. The possibilities for the document camera are limitless.

4. Give a time schedule of implementation.

We, the special education teachers for 4<sup>th</sup> through 7<sup>th</sup> grade, would be able to implement the document camera as soon as we receive and set up the camera. We are excited to expand our teaching to innovative technology in our classrooms and keep up with the other classes.
